## 2022 Western States Bar Conference

## **Speakers**



Daniel "Kaniela" Kahikina Akaka, Jr. was born and raised in Nu'uanu and Pauoa Valleys. He received his B.A. in Hawaiian Studies from the University of Hawai'i. Mr. Akaka is presently employed at the Mauna Lani Auberge Resorts Collection on the Island of Hawai'i, as the Kahu Hānai of the Living Culture Department. His position at the resort allows him to share the history and culture of Hawai'i with the hotel guests as well as the many school groups that come to Mauna Lani to learn about Hawaiian aquaculture as well as the history and stories of this ancient land known as Kalāhuipua'a.

Although he has been employed at Mauna Lani for 39 years, his business career has also included Aloha Airlines, Hawaiian Holidays, the Hawai'i Maritime Center, and American Hawai'i Cruises. In his work today, Mr. Akaka is involved in perpetuating the culture, the essence, and the Spirit of Hawai'i. To that end, he serves on a number of boards, including for the Bishop Museum, the Akaka Foundation for Tropical Forests, and the Hawaiian Music Hall of Fame.

Mr. Akaka comes from a family of seven, which include his parents, Daniel (deceased) and Millie Akaka. He and his wife, formerly Anna Lui-Kwan (KS Class '72), have 5 children, one daughter, four sons and 2 grandchildren with one more on the way.



**Erwin Chemerinsky** is Dean and Jesse H. Choper Distinguished Professor of Law, University of California, Berkeley School of Law. Prior to assuming this position, he was the founding dean of the University of California, Irvine School of Law, and a professor at Duke Law School, University of Southern California Law School, and DePaul Law School.

He is the author of 14 books, including leading casebooks and treatises about constitutional law, criminal procedure, and federal jurisdiction. He also is the author of more than 200 law review articles. He is a contributing writer for the Opinion section of the Los Angeles Times, and writes regular columns for the Sacramento Bee, the ABA Journal, and the Daily Journal, and frequent op-eds in newspapers across the country. He frequently argues appellate cases, including in the United States Supreme Court.

In 2016, he was named a fellow of the American Academy of Arts and Sciences. In 2017, National Jurist magazine again named Dean Chemerinsky as the most influential person in legal education in the United States. In January 2021, he was named President-elect of the Association of American Law Schools.



**Zachariah J. DeMeola** is the Director of Strategic Initiatives at the Law School Admission Council (LSAC). Until recently, Zack was the Director of Legal Education and the Legal Profession at the Institute for the Advancement of the American Legal System (IAALS), a national, independent research center at the University of Denver dedicated to facilitating continuous improvement and advancing excellence in the American legal system. At IAALS, he worked to improve the delivery of legal services through projects focused on education, licensing and admission into the profession, the intersection of law and technology, and the regulation of the legal profession. A former lawyer himself, DeMeola led the IAALS Unlocking Legal Regulation Project.

Today, as the new Director of Strategic Initiatives at LSAC, Zack contributes to new and innovative ways to educate and train lawyers while opening the profession to include more diversity. Zack remains committed to supporting

regulatory innovation and continue that work on his own time. He is a featured speaker on these issues and his writings appear in publications across the country. He is also an advisor to states seeking guidance on regulatory innovation and access to justice.

Zack is a member of the Governing Council of the ABA Center for Innovation and a co-founder of the Denver Legal Hackers. He graduated from William & Mary School of Law, obtained a Master's degree in American Studies from the College of William and Mary, and received his B.A. from the University of Pennsylvania.



**Joel F. England** currently serves as Chief Executive Officer and Executive Director of the State Bar of Arizona. Before coming to the Bar, Joel was the Chief Judge of the Yavapai-Apache Nation, a federally recognized Indian Tribe in Camp Verde, Arizona. He was responsible for the overall administration of the Court and presided over criminal and civil cases as well as an alternative disposition Wellness Court.

Prior to being a judge, he served for over 21 years in the United States Air Force. He held a variety of positions, including service as a prosecutor, defense counsel and as a deployed combat operations attorney advising on the law of armed conflict. His final assignments included serving as the Chief of Professional Responsibility for the Air Force Judge Advocate General's Corps and as the General Counsel for the 56th Fighter Wing at Luke Air Force Base. During his tenure at Luke Air Force Base, his team was recognized as the Arizona Corporate Counsel In-House Legal Department of the Year in 2016.

Joel graduated with academic distinction from the United States Air Force Academy with a B.A. in Legal Studies. He holds a JD from the University of Arizona College of Law, where he graduated summa cum laude and served as the Editor-in-Chief of the Arizona Journal of International and Comparative Law. Joel is a member of the Arizona, California, and District of Columbia bars.



**Deborah Enix-Ross**, a senior adviser to the International Dispute Resolution Group of Debevoise & Plimpton in New York City, is president-elect of the American Bar Association. Enix-Ross served as chair of the ABA House of Delegates, the ABA Center for Human Rights, the ABA International Law Section, and the ABA Section Officers Conference. She has also served as vice chair of the International Bar Association's Bar Issues Commission, ABA representative to the IBA, and as vice president of the World Justice Project.

Enix-Ross joined Debevoise & Plimpton in 2002. Previously, was senior legal officer with the World Intellectual Property Organization Arbitration and Mediation Center in Geneva, Switzerland. She also was a director of international litigation with Price Waterhouse and the American representative to the International Chamber of Commerce International Court of Arbitration.

Enix-Ross was appointed as one of the original eight U.S. members of the trilateral NAFTA Advisory Committee on Private Commercial Disputes. She is a member of the Advisory Committee of the New York Law School Alternative Dispute Resolution Skills Program. She is also a former member of the advisory board of the Institute for Transnational Arbitration, the ADR Advisory Board of the International Law Institute, and the Board of Directors of the American Arbitration Association.

Enix-Ross earned a B.A. in broadcast journalism from the University of Miami and J.D. from the University of Miami School of Law. She also received a diploma in comparative law from the Parker School of Foreign and Comparative Law of Columbia University and a certificate in international law from the London School of Economics.



**Eric J. Farber** is the Founder and CEO of Creators' Legal, the Legal Zoom for the Entertainment Business, the first and only DIY Legal Platform for content creators. Prior to founding Creators' Legal, Mr. Farber spent over 20 years as a Sports and Entertainment attorney. He represented Amaru Entertainment (the Estate of Tupac Shakur) for more than 18 years, as well as dozens of professional athletes and highly visible businesspeople. Mr. Farber is also the Founder and former CEO of Pacific Workers, The Lawyers for Injured Workers, which he grew from 4 people to over 80 with 6 offices.

In 2020, Mr. Farber published The Case for Culture, How to Stop Being a Slave to Your Law Firm, Grow Your Practice and Actually Be Happy. The Case for Culture, quickly hit #1 Bestseller on Amazon and was named by

Forbes as a top 8 book to "rethink work relationships."

Mr. Farber was on the Cultural Affairs Commission of the City of Oakland. He is a former president of the Inns of Court of San Francisco and formerly on the Board of Advisors for the Entrepreneurship Program at the Studio School, a Film and Acting University based in Los Angeles, where he also served as their first entrepreneurship professor.

In 2022, Mr. Farber was appointed to the United Nations commission on Latin American Human Rights. He grew up in Toronto, Canada and Phoenix, Arizona. Mr. Farber has a B.A. in Political Science from Arizona State University and a J.D. from Golden Gate Law School.



**Judge Robert D.S. Kim**, was sworn in on November 21, 2017, by Chief Justice Mark E. Recktenwald to serve as Judge of the Circuit Court of the Third Circuit (Kona). He is Chief Judge for Third Circuit and was an active participant in the Chief Justice Committee on Operations, which was established to address court operations issues due to COVID.

Prior to his appointment, Judge Kim was in private practice concentrating in criminal defense, family law, civil litigation, personal injury, and other administrative proceedings. He graduated from the University of Hawaii-Hilo with a B.A. in Political Science, and from the William S. Richardson School of Law at the University of Hawaii at Manoa.



Ann Morgan is a Director in the employment and labor law group at Fennemore Law in Reno, Nevada. Her work includes employment law, aviation and general business law matters. She serves in a general counsel capacity to private individuals as well as the Reno-Tahoe Airport Authority. **Lucy Ricca** is the Director of Policy and Programs for the Stanford Center on the Legal Profession. Before starting this role, Ricca was the first Executive Director of the Utah Office of Legal Services Innovation, a new regulator of legal services launched by the Utah Supreme Court.

Ricca has been immersed in the movement to reform regulation of the legal profession to increase innovation, market diversification, and access to justice. She was a Special Project Advisor at the Institute for the Advancement of the American Legal System ("IAALS"), advising on the Unlocking Legal Regulation project. She served as the Executive Director of the Stanford Center on the Legal Profession from 2013 – 2018. She also served as a Lecturer at Stanford Law School and has written on the regulation of the profession, the changing practice of law, and diversity in the profession.

Ricca clerked for Judge James P. Jones of the United States District Court for the Western District of Virginia. Before clerking, Ricca practiced white collar criminal defense, securities, antitrust, and complex commercial litigation as an associate at Orrick, Herrington & Sutcliffe. Ricca received her B.A. cum laude in History from Dartmouth College and her J.D. from the University of Virginia School of Law.



**Dean Stephen Rispoli** earned his political science degree from Baylor University in 2009, his J.D. from Baylor Law in 2012, and his LL.M. from the University of Texas School of Law in 2018. Rispoli serves as Assistant Dean of Student Affairs and Strategic Initiatives and as the Director of Innovation and Scholarship for the school's Executive LL.M. in Litigation Management.

Currently, Matthew is the Associate Director of Legal Technology at Harvard Law School's Access to Justice where he conducts randomized controlled trials to determine which interventions in access to justice issue work

and which do not. He is also an adjunct professor at the University of Hawaii at Manoa, William S Richardson School of Law.
