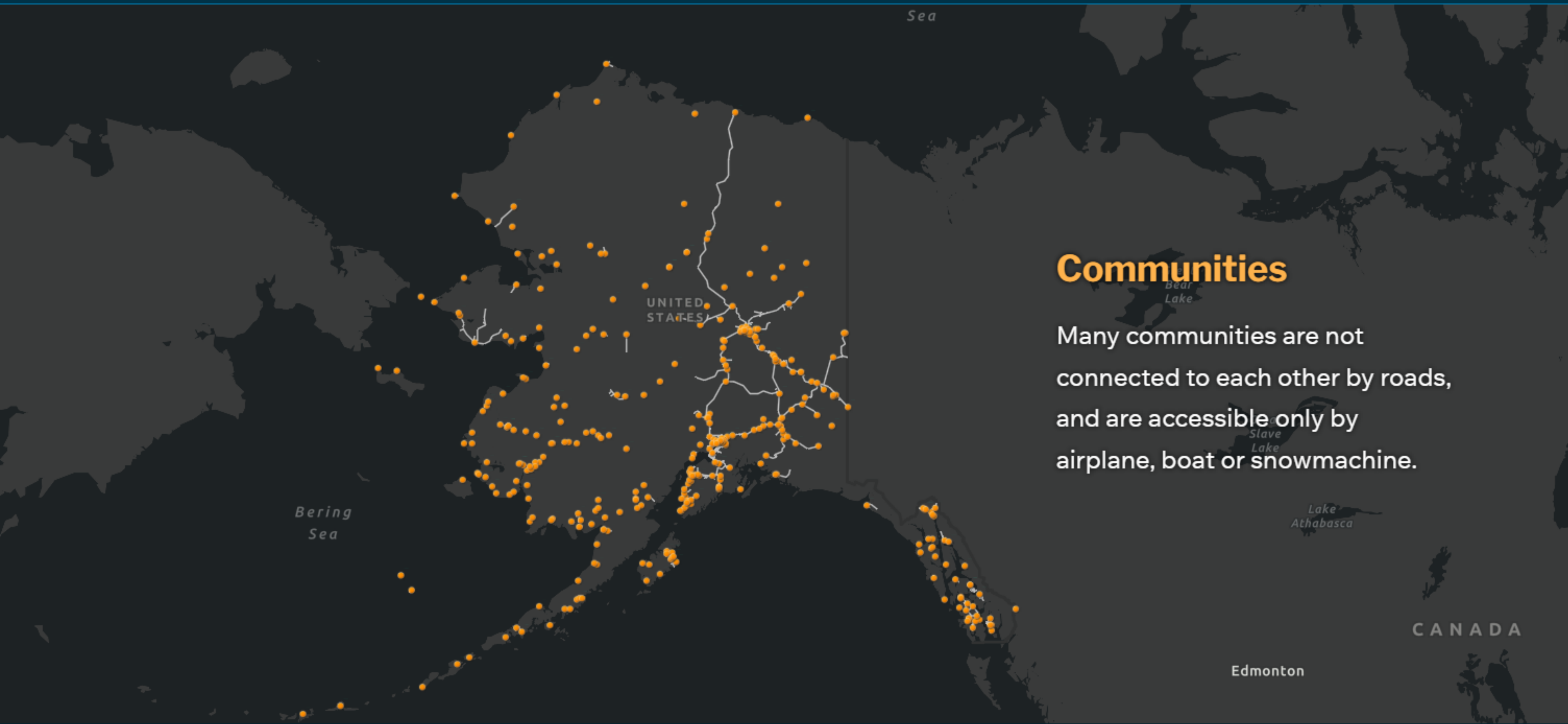
Alaska is home to 740,000 people. The state's far-flung communities are dotted across a huge expanse, covering an area one-fifth the size of the continental United States.

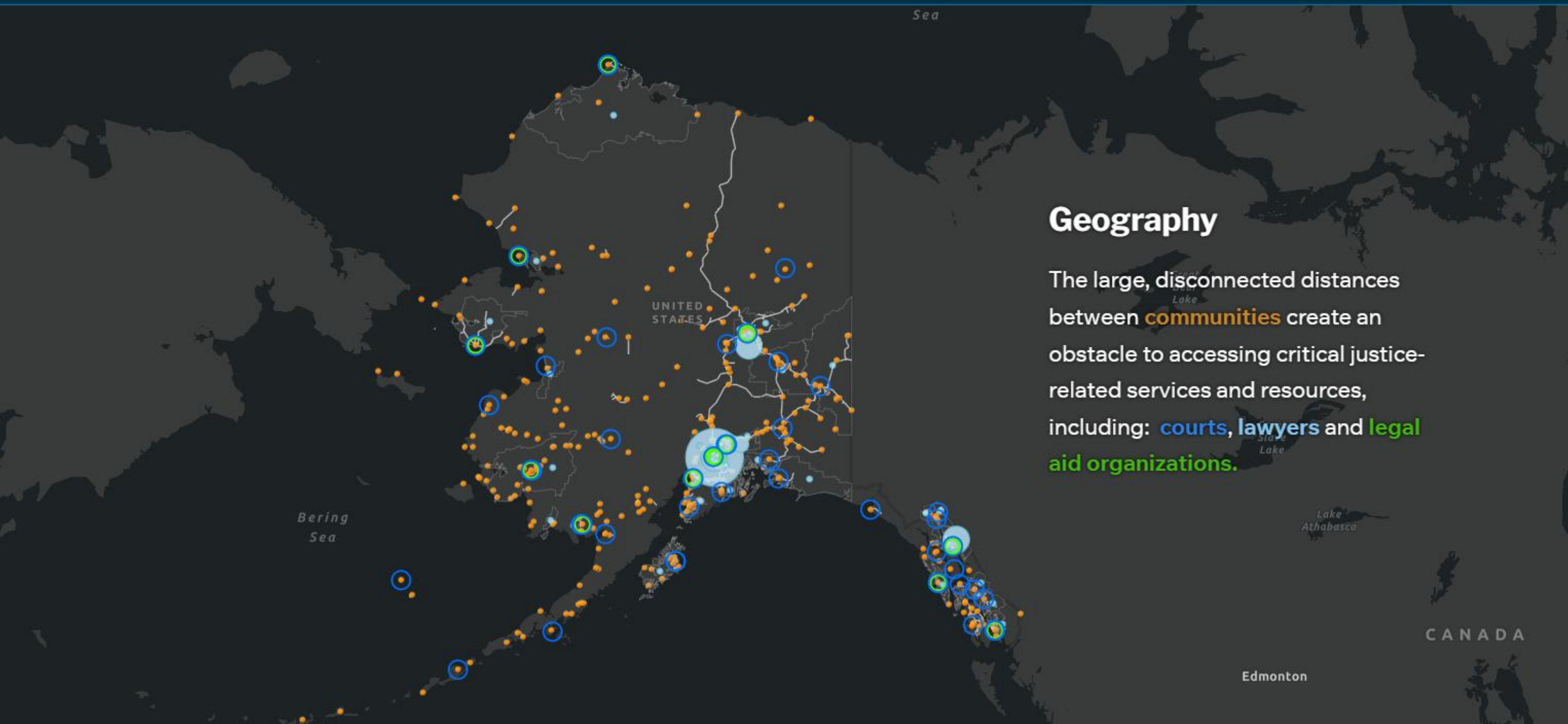

Communities

Many communities are not connected to each other by roads, and are accessible only by airplane, boat or snowmachine.



Geography

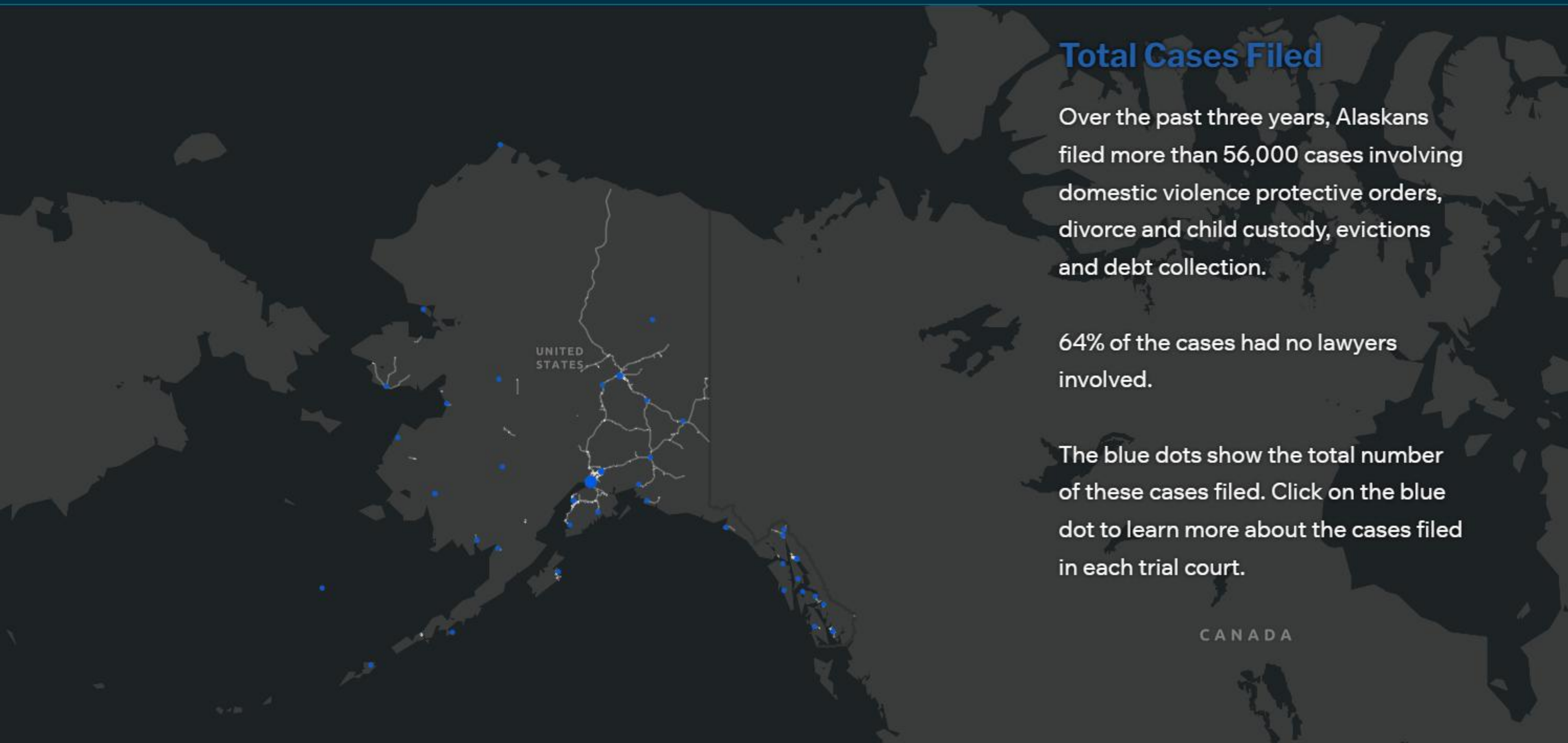
The large, disconnected distances between **communities** create an obstacle to accessing critical justice-related services and resources, including: **courts**, **lawyers** and **legal aid organizations**.

Total Cases Filed

Over the past three years, Alaskans filed more than 56,000 cases involving domestic violence protective orders, divorce and child custody, evictions and debt collection.

64% of the cases had no lawyers involved.

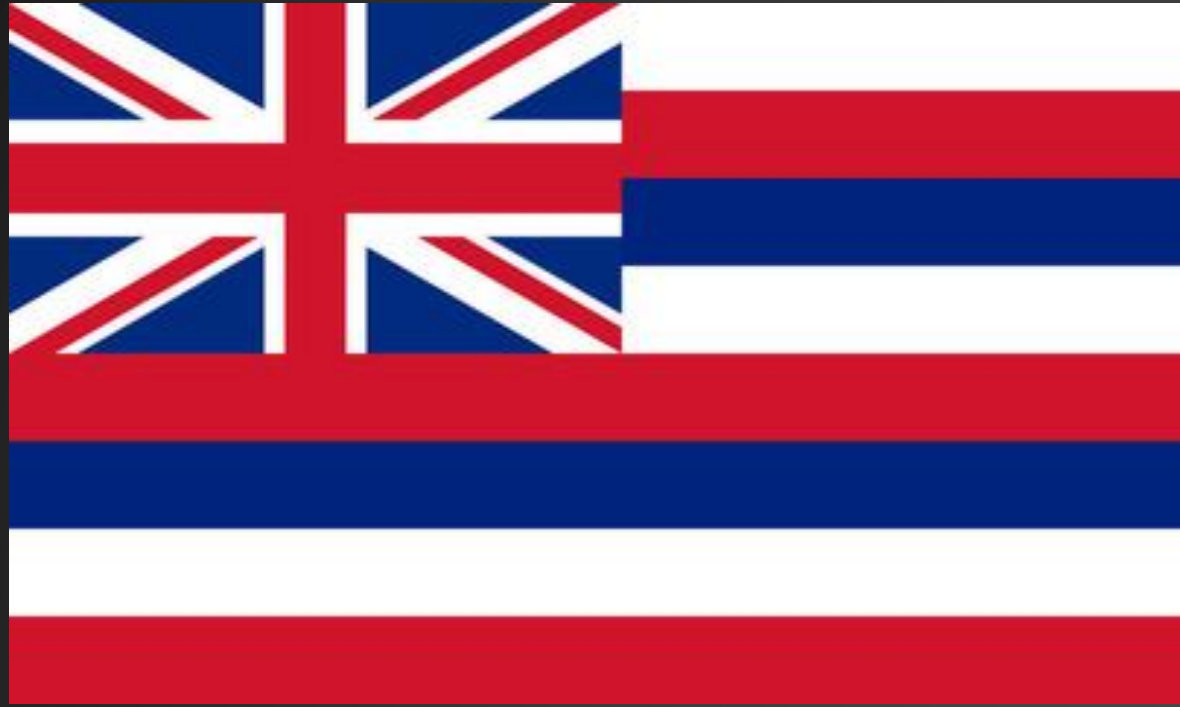

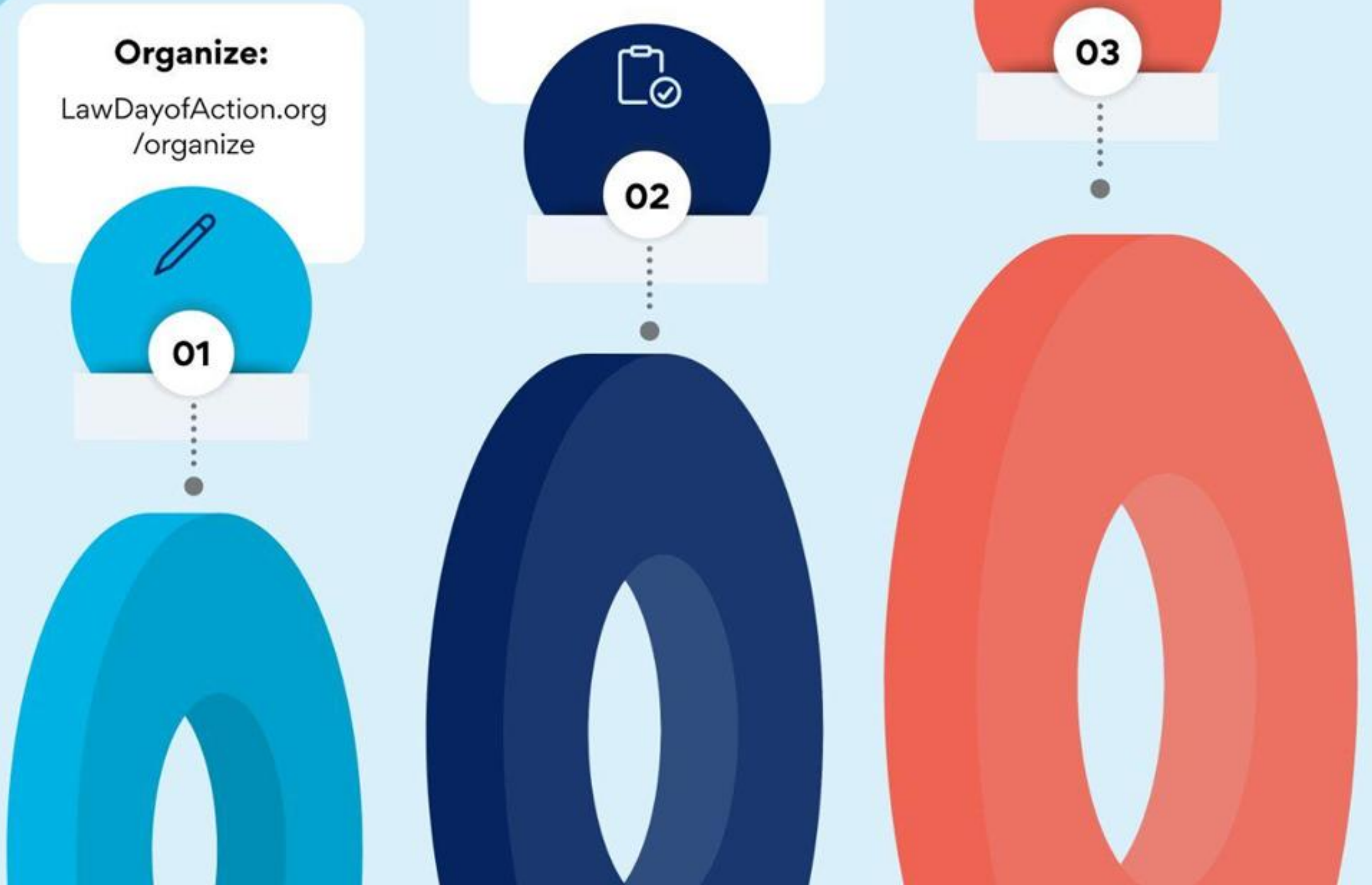

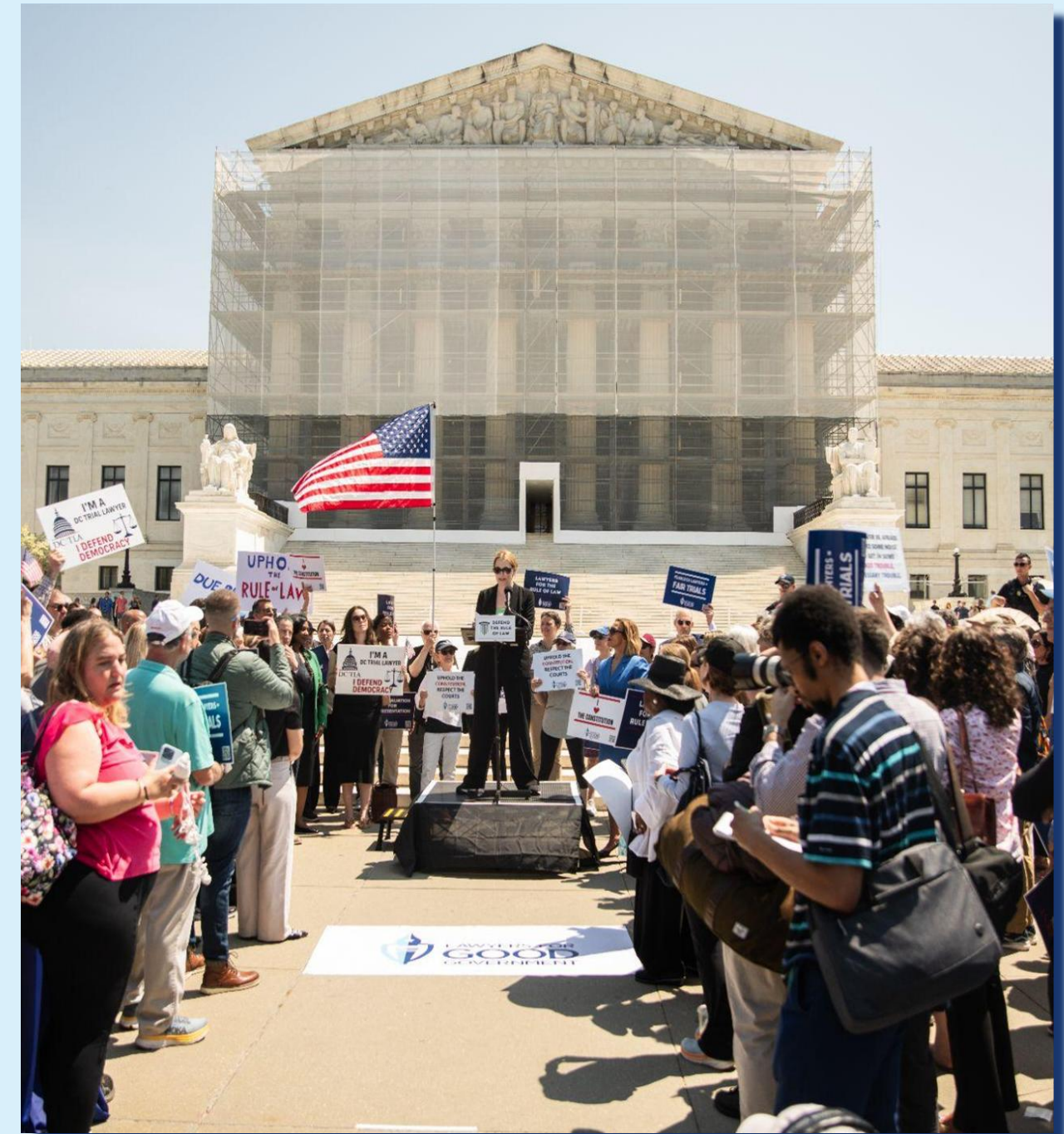
